Parking permits are non-transferable and may not be given or sold to another student driver. Any unauthorized use of this permit (by anyone other than the principal owner and/or in vehicles other than the two vehicles designated above) may result in revocation of the permit and forfeiture of the permit fee.*

## SCHEDULE OF FEES

Annual Parking Permit Fee - \$50.00 (pay [HERE](#))  
Citation Fee (per occurrence) - \$5.00

Reissue Fee (Lost Permit) - \$5.00  
Boot Removal Fee - \$5.00

*The parking permit entitles the permit's principal owner parking privileges on campus for the academic year, Monday through Friday during school hours (7:45am to 3:45pm). If lost, the permit will be reissued following payment of a reissuing fee. Violations of campus parking regulations may result in additional fees for citations or boot removal.*

*The permit must be displayed on the driver's side dashboard at all times while parked on campus.*

## **CAMPUS PARKING REGULATIONS**

The applicable traffic and parking laws of the State of Arizona and City of Chandler will be observed by student drivers at all times. In addition, student drivers must observe all traffic and parking policies outlined in the Chandler Preparatory Academy Family Manual.

Speed limit in the parking lot is 10 miles per hour. Student drivers agree to exercise considerable vigilance and extreme caution while driving the parking lot. Students must exit the parking using the traffic flow pattern illustrated in the Chandler Preparatory Academy Family Manual.

Chandler Preparatory Academy is a closed campus. Students are expected to immediately park their cars upon arrival at school and remove all items required for the school day. Students are not permitted to return to their cars or drive off campus prior to the dismissal of school for the day without permission from the administration (exception - student driver is dismissed from school by parent communication with the front office).

Vehicular accidents that occur in the parking lot will be the responsibility of the drivers involved, to include all expenses and liability resulting from the accident. Driver agrees to hold harmless Chandler Preparatory Academy and Great Hearts Academies from any liability or expense resulting from a collision between two or more vehicles while on school property.

Vehicles parked on school property are under the jurisdiction of the school. The school reserves the right to boot, cite or revoke the permit of any vehicle for a violation of school regulations. A vehicle search may be conducted at any time there is reasonable cause to do so, with or without the presence of the student driver or owner of the car.

Student drivers park at their own risk. Student drivers have full responsibility to secure their vehicles for the period of time the vehicle is parked on school property. Chandler Preparatory Academy and Great Hearts Academies is not liable for any damage to or theft of contents from vehicles parked on school property.

Vehicles shall be parked only in areas designated for student parking and only in designated parking spots. Student parking is located on the southern or eastern sides of the school building only. Students drivers should never park in the following areas:

- AREAS INDICATED AND MARKED AS "FIRE ZONES";
- AREAS BLOCKING ROADWAYS, DRIVEWAYS, OR INTERSECTIONS;
- AREAS BLOCKING ENTRANCES, IN SERVICE DRIVEWAYS OR IN LOADING ZONES;
- AREAS DESIGNATED WITH "NO PARKING" SIGNS;
- AREAS MARKED "RESERVED", DESIGNATED FOR VISITORS PARKING OR COVERED PARKING; or,
- AREAS DESIGNATED FOR HANDICAPPED INDIVIDUALS (UNLESS STUDENT QUALIFIES AS DISABLED).
