- Approve minutes from December 5th 8:30-9:30pm in the CPA Library (minutes approved)
- Committee updates
 - Lunch Calendar Coordinator/Lunch Sales and Concessions sell Ramen and mac n cheese at HS - always need new lunchroom volunteers - We increased prices - Selling plastic forks etc. - Drink vending machines?
 - Ramen and mac n cheese will be sold at HS lunch only. \$1.50 for each.
 - Forks will sell for \$.10 each.
 - Last week of December sold 311 meals v. first week of January 335 meals (increase of \$150)
 - Discussion to add back in the drinking vending machine. Agreed to try to set that up (but no specific timeframe as to when)
 - Discussion of adding Jamba Juice on Fridays (3 flavors). Can sell for \$1 over what Jamba Juice charges. Need approval from Mr. Poppleton. May need a 3rd lunch volunteer to help with those sales
 - A. Rodriguez has someone contacting Jamba Juice & also looking into selling pizza slices for finals
 - Discussion of having a general sign up genius for Fridays only so that any parent can volunteer whenever they want (will do this if we can get approval for Jamba Juice)

 - Decision to sell shirts (with new design) for \$20 each, will order 30 shirts (15 Adult Small and 15 Adult Medium)
